

WHEREAS, the Village of Rye Brook previously adopted a Resolution dated July 2, 2015 agreeing to enter into an agreement with Sustainable Westchester authorizing the Mayor to execute any and all documents with respect to the Community Choice Aggregation program ("CCA Program") in Westchester County which would allow the Village Board to participate in a program with Sustainable Westchester to procure energy supply from energy services companies for the residents of the Village;
