Westchester Power (CCA) - This community choice aggregation program is New York State's first such program, serving 27 municipalities including over 100,000 residents and small businesses in Westchester County.

Clean Transportation - This program serves to guide the County's municipalities in converting their mobile fleets to electric vehicles and encourages the installation of electric vehicle charging stations in locations accessible for public use. The program was expanded this past year to include incentives for all Westchester County residents to purchase electric vehicles thereby substantially reducing carbon emissions in our communities.

Waste Management and Materials- This program assists our member-municipalities in communicating their local recycling schedules and processes at a lower (group) cost to each municipality.
