THIS COMMUNITY ENERGY PROGRAM IS THE FIRST OF ITS KIND IN NEW YORK STATE AND SERVES AS THE STATE MODEL. THIS ELECTRICITY SUPPLY PROGRAM CURRENTLY SERVES 29 MUNICIPALITIES AND APPROXIMATELY 145,000 ACCOUNTS.
