Property Ownership Documentation

WHAT WE NEED: Property Title or Deed with...

- Organization name that matches SAM.gov Organization Name and
- Street Address that matches building address

If Street Address isn't on title/deed:

- Include a PDF of the local state or county Property Search database(typically a County assessor or recorder property search or GIS tool)
- Make sure the tool notes the property owner, and that the owner name matches the SAM.gov name)
- Make sure the property legal description on the title/deed matches the legal description in the property search tool.
- If you can't find a state/county database with property ownership information, provide any other documentation to show ownership and we will confirm and possibly run by our General Counsel.

If the Organization Name doesn't match:


• Provide official documents that show the connection between the Property Owner Org Name and the SAM.gov name (i.e. a name change filing with the state).

Note: These are recommendations to support the property ownership review process. Individual property ownership reviews may require additional review and/or steps with DOE.






Find the County Property Search Site

- Do a search for the "<u>County"</u> and "<u>Real Property</u> <u>Search</u>."
- Look for a county government result (typically Assessor website)
- Alternatively, navigate over to the local county's website directly to find the assessor webpage.

Review the Parcel information

- Confirm legal description matches the Title/Deed legal description
- Confirm organization name matches SAM.gov (note in this example we'd want to make sure that Seattle Humane's organization name is "Humane Society" on Sam.gov)
- Save a PDF of the document showing the local government website of your search.
- Note: some local governments require a registration to get this information, and/or may charge for this information. We aren't requesting you do that.
