In January 2023, the Westchester County Office of Economic Development and Sustainable Westchester launched the Clean Energy Accelerator program, which aims to identify the needs of the local green economy, accelerate a just transition to clean energy and train the climate career workforce. As part of the Clean Energy Accelerator, a Careers Work Group was formed, which meets quarterly and connects clean energy industry employers, higher education institutions, technical trade schools, and job seekers. Their efforts will increase clean energy training opportunities based on real-world needs and pave a pathway to the local job market.

Born in Zambia to parents devoted to public service, Kaela Mainsah has built her career on the same values of equity and empowerment. As Vice President of Environmental Justice at the New York Power Authority (NYPA), she brings over 15 years of experience in environmental policy and engineering management across the U.S. and U.K.

Kaela leads one of the energy industry's most innovative and award-winning Environmental Justice (EJ) programs, rooted in the principle of Being a Good Neighbor. She believes education is key to breaking the cycle of poverty, which is why educational equity is at the heart of NYPA's EJ efforts.

Under her leadership, NYPA's EJ program offers no-cost, energy-focused STEM education and career readiness programs for students in grades 3–12, covering topics like electricity, climate change, hydroponics, and environmental stewardship. Adults also benefit from energy literacy workshops on weatherization, solar power, and emergency readiness.

The EJ program also funds major community energy service projects, including initiatives with the Niagara Falls Housing Authority and the Tuscarora Elementary School, serving Indigenous students in Lewiston, NY. Kaela holds a master's in Public Administration – Environmental Science and Policy from Columbia University (U.S.), a Postgraduate Certificate in Engineering Management from Cambridge University (U.K.), and a bachelor's in Chemical Engineering from Aston University (U.K.).

She lives in Purchase, New York with her husband and is the mother of three adult children.



PAUL PRESENDIEU
POLITICAL ACTION LEAD,
WE ACT 4 CHANGE

Paul Presendieu of New Rochelle is the Political Action Lead at WE ACT 4 Change, the 501(c)4 political arm of WE ACT for Environmental Justice. The organization advances environmental justice by giving voice to those affected by environmental hazards through direct political empowerment.

Paul also currently serves on the Executive Committee of the Democratic National Committee's Council on the Environment and Climate Council, where he was the first New York resident democratically elected by the Democratic National Committee to support climate leadership for the national party and state parties. Paul is also in his second term as the National Environmental Caucus Chairman for the Young Democrats of America, and is the first Democrat in history to have served as the National Environmental Caucus Chairman for the Young Democrats of America and College Democrats of America. Paul proudly serves on the Adult Advisory Board for the High School Democrats of America.

Paul is an accomplished young professional, having been named to six separate 40 under 40 lists, and being recognized by the Clinton Global Initiative and Grist as one of the Top 50 Climate Leaders to Watch in the United States of America during the United Nations 79th General Assembly.

Raya Salter, AKA "Climate Auntie" is an energy justice movement attorney, activist, author, and the Founder and Executive Director of the Energy Justice Law & Policy Center, based in New Rochelle, NY. EJLPC is focused on building grassroots power and youth leadership for environmental justice and community leadership for green and clean infrastructure.

Raya is a member of the New York State Climate Action Council, an adjunct professor at Cardozo Law School, and the author of "Energy Justice" (2018). She has over 15 years of energy regulatory experience both in private practice (Dewey & LeBoeuf) and for NGOs, including the NY Renews Coalition, NRDC, and the Environmental Defense Fund.
